1. Jamia Millia Islamia

Jamia Millia Islamia is a comprehensive research-intensive Central (Public) University. The university made a modest beginning in 1920 at Aligarh, and later moved to Delhi in 1925. It is the result of the tireless efforts of its founders; Shaikhul Hind Maulana Mahmud Hasan, Maulana Muhammad Ali Jauhar, Jenab Hakim Ajmal Khan, Dr. Mukhtar Ahmad Ansari, Jenab Abdul Majeed Khwaja, and Dr. Zakir Hussain to create an institution that would manifest indigenous ethos and spirit of plurality. Jamia Millia Islamia, in 1988 became a Central University by an Act of Parliament. It is a national institution that offers progressive education and nationalist ideals to students from all communities, particularly the Muslims, providing them with cutting edge learning experience, internationally benchmarked education, intellectual freedom and research opportunities in frontier areas of contemporary fields.

Today Jamia Millia Islamia is ranked at 04 th position in the country amongst universities in NIRF 2025 rankings issued by the Ministry of Education, Govt. of India. It was accredited with the highest grade of 'A++' by the NAAC, Ministry of Education in the second cycle of assessment in 2021. The university has also been consistently ranked amongst leading universities in the world by the renowned international ranking agencies as a comprehensive research-intensive institution. The university has received the prestigious “Research award of President of India” twice and many of its students are recipients of Prime Minister’s research fellowship. Several researchers of the university figure in the recent list of the World's Top 2% Scientists issued by the Stanford University.

The university recognizes both teaching and research as areas of focus. It has Natural Sciences, Social Sciences, Engineering & Technology, Education, Humanities & Languages, Architecture & Ekistics, Fine Arts, Law Dentistry and Management Studies Faculties. Jamia has over thirty research Centres of higher studies and research in diverse domains of contemporary concern. Some notable Centres are AJK Mass Communication Research Centre, Centre for Peace and Conflict Resolution, Academy of International Studies, Centre for Culture, Media and Governance, Centre for Nano sciences and Nanotechnology, FTK Centre for Information Technology, Centre for Management Studies, Dr. K.R. Narayanan Centre for Dalit & Minority Studies, Centre for West Asian Studies, Centre for Physiotherapy & Rehabilitation Sciences, Centre for Theoretical Physics, Centre for Interdisciplinary Research in Basic Sciences and Multidisciplinary Centre for Advanced Research and Studies. The university continues to support measures for affirmative action to foster the goals of building a secular and modern system of integrated education.

Spread across 239 acres, the university is a partly residential campus where students come from different parts of the country and abroad. It provides them a safe and friendly environment to become part of the plural, diverse and inclusive fabric of the university. A range of co-curricular and extracurricular activities, sports facilities, and several cultural clubs are available for students, ensuring their overall growth.

2. Centre for Distance and Online Education

The Centre for Distance and Open Learning (CDOL) was established in September 2002 with the support of the Distance Education Council (DEC), based at the IGNOU campus in Delhi. The DEC was later dissolved, and in 2013, the Distance Education Bureau (DEB) was created to formulate policies for governing higher education institutions (HEIs) offering distance education. Additionally, in 2009, the Ministry of Human Resource Development (MHRD) of the Government of India also approved the Centre. Owing to Covid and resultant disruption in the way formal education was being imparted; Regulation 2020 of DEB made it mandatory for Distance Educational institutions in a dual mode university to rename their HEIs as Centre for Online Education, therefore the Centre was renamed as Centre for Distance and Online Education (CDOE).

The Centre aims to provide access to higher education for individuals who cannot benefit from traditional educational systems, ensuring that learning is available at the doorstep of every learner. To support this mission, the Centre offers comprehensive self-learning material (SLM) created by subject experts, designed to accommodate learners from diverse educational backgrounds. These materials are complemented by counseling sessions conducted by teachers who provide invaluable assistance to distance learners. In response to evolving technological advancements, the Centre has also adapted its approach by conducting classes through online platforms as well.

To enhance accessibility, the Centre has established Learner Support Centers (LSCs) across various states in India. These LSC's are located at far flung and at times in remote locations of the country. These LSCs also play a crucial role in reaching out to learners from rural areas.

Over the years, CDOE has experienced significant growth in student enrollment and course offerings. In 2002, the Centre offered just five programs, including B.Ed, Diploma in Power Generation Engineering (DPGE), DECCE, and MA in English and Hindi. Today, it provides 50 undergraduate, postgraduate, diploma, and certificate programs; with annual enrollments of approximately 20,000 students—comparable to regular student numbers in JMI.

Currently, the Centre employs 30 Assistant Professors and nearly 40 administrative staff to support operations. The growing student population places immense pressure on service delivery, making it crucial for CDOE to continue its evolutionary role and by engaging a wider cross section of student community.. In alignment with the NEP-2020 roadmap for enhancing higher education and improving the Gross Enrollment Ratio, it is essential for Higher Educational Institutions (HEIs) to carry forward the mission of Government of India by providing more accessible, quality education to students and the Centre continues to fulfill such requirements as well.

2.1 Open and Distance Learning (ODL) & Online Learning (OL) Mode Programmes

“Online Learning Mode means a mode of providing flexible learning opportunities by overcoming separation of teacher and learner using internet, e-Learning Materials and full- fledged programme delivery through the internet using technology assisted mechanism and resources”.

“Open and Distance Learning Mode means a mode of providing flexible learning opportunities by overcoming separation of teacher and learner using a variety of media, including print, electronic, online and occasional interactive face-to-face meetings with the learners or Learner Support Services to deliver teaching-learning experiences, including practical or work experiences”.

The Centre for Distance and Online Education, JMI is one of the few reputed Higher Education Institutes to provide the UG, PG, and Diploma Programmes in Open and Distance Learning (ODL) as well as Online Learning (OL) mode. CDOE has been providing Online Degree programmes since 2021. The Centre aims to make optimum use of technological advancement in imparting Education through the Online Mode and facilitate the learners with ease. Given the recent developments in the area of education and resultant positive changes, the Centre has

also adopted varied Online Methods of Evaluation and Online Teaching. Such use of technology has bridged a gap between the learner and facilitator and made education more accessible to learners based in far-flung areas. Moreover, these Online Programmes are also accessible to Foreign Nationals who are interested in pursuing education at our Institute.

Personality by choosing subjects across disciplines and mediums. The CDOE would like to encourage interdisciplinary among students in their studies. To facilitate this, a cumulative list of courses that will run under CBCS is being provided. Students are advised to go through the list carefully so that they can make an informed choice. Assistant Professors or Programme Coordinators may be contacted for advice or any other help related to the CBCS.

2.2 Centre for Internal Quality Assurance (CIQA)

The UGC (ODL) Regulations 2020 make it mandatory for dual-mode universities to establish a Centre for Internal Quality Assurance (CIQA) exclusively for their distance mode programmes. The objective of CIQA is to develop and put in place a comprehensive and dynamic quality assurance system to provide high-quality programmes of higher education in the distance and online learning mode. Accordingly, the Vice Chancellor constituted the CIQA Committee to monitor the qualitative mechanism of the Centre; the committee consisted of the following members:

- ❖ To encourage the creation and dissemination of knowledge using the latest educational tools and technologies.
- ❖ To create environmental and societal responsibilities among students and ensure steady growth of the University.
- ❖ To trust every individual and treat them with dignity, respect, and fairness by always practicing open and honest communication.

2.4 Instructional System

The distance and online education programme delivery system include the multi-media approach, i.e., self-learning material available in hard copy and soft copy (PDFs), audio/video components, assignments, counselling sessions, practical work, discussion forums, and workshops.

2.5 Learner Support Centres (LSCs)

“Learner Support Centre means a center established or recognised by the Higher Educational Institution for advising, counselling, providing interface between the teachers and the learners, rendering any academic and any other related service and assistance required, inter alia, by the learners of Open and Distance Learning mode”.

It is a contact point to provide academic as well as administrative support to its learners. All the important communications are sent to the Centre Coordinator of the Learner Support Centre. A copy of important circulars/notifications will be displayed on the notice board of the Learner Support Centre to provide the latest information about the assignments, submission of the examination forms, date sheet, list of admitted students, declaration of result, etc. Extracurricular activities encouraged at the Learner Support Centre like Annual Day, Sports Day, Literary Competitions, etc. are held and encouraged.

2.6 Self-Learning Material (SLM)

The e-copy (soft copy) of Self Learning Material for both theory and practical components for each programme of study is provided to all the learners of ODL as well as OL mode. The PDFs of the SLM are uploaded to the Google Classroom of each respective programme. The SLM of each course/paper in each programme is prepared in the form of blocks and units. Normally each course is divided into 3 – 5 blocks and each block contains 3 – 5 units. The code for each

course under each programme is different so that it may be identified and accessed comfortably.

The fee for the e-copy of SLM is included in the programme fee. However, the hardcopy of the SLM is provided ON DEMAND to the learners of ODL mode only as per the following extra charges:

Note:

1. In online mode, there is no provision of On Demand Print SLM. Online mode is devoted towards a paperless and environmentally sustainable approach.
2. In ODL (Open and Distance Learning) mode all students are supplied with the soft copy of SLM (PDF/e-form of SLM), but there is a provision of providing SLM in print form/hard copy on demand. We encourage students to use e-SLM and be environmentally sustainable in their approach, but still if they need to have the hard copy of SLM they may submit the requisition form along with the DD/payment receipt of the required amount (as shown in table above) at the LSC counter.

2.7 Audio and Video Programmes

The Audio and Video Programmes are supplementary, meant for clarification and enhancement of understanding in various courses of the Programme. These are used during Counselling and workshop sessions at the Learner Support Centres. The information regarding Online Educational Resources (OERs) shall be made available to the learners during counselling sessions.

2.8 Library Facility

The CDOE has developed its own library with around 1000 books. In addition, the library has the facility of air conditioned reading room. The library facility can be availed with the permission of the concerned Programme Coordinator.

2.9 Counselling Sessions

Counselling sessions are held at the Learner Support Centres (LSCs), normally on weekends and during long holidays, within the general academic schedule of the programme. The counselling schedules are shared well in advance by the LSCs and the Programme Coordinators through Google Classrooms, as well as on the official CDOE webpage (<https://cdoejmi.ac.in/conselling-workshop-schedule/>) and the Jamia Millia Islamia website ([https://www.jmi.ac.in/Centre-For-Distance-And-Online-Education-\(CDOE\)/Counselling/-Workshop-Schedule](https://www.jmi.ac.in/Centre-For-Distance-And-Online-Education-(CDOE)/Counselling/-Workshop-Schedule)).

The counselling duration and time for each theory course will consist of 6 sessions of 2 hours each.

The **counselling sessions for ODL Programmes** are held at the Learner Support Centres.

However, the CDOE has decided to conduct the counselling sessions in a blended mode as per UGC-DEB guidelines. For **Online Learning (OL) programmes**, all the counselling sessions and all other academic activities are conducted in purely online mode.

The counselling sessions are taken by faculty members and experts from the field. The counselling sessions will include clarifications required in the SLM and other related difficulties through active interaction with students. Attending counselling sessions is optional, however, presence and participation in the counselling session are highly beneficial for the learners and their academic growth. The e-SLM in the form of videos and PDFs will be uploaded on the respective Google Classrooms.

2.10 Medium of Instructions

In most of the programme of study, the medium of instruction is English. The self-learning materials and assignments in the programmes will be primarily available in English. For the Post Graduate programmes, the semester-end question papers will be in English only. Students can attempt their assignments and Term-End/Semester-End examination papers either in English, Hindi, or Urdu.

2.11 Website

The Centre for Distance and Online Education (CDOE), Jamia Millia Islamia has a dedicated website that is regularly updated with notifications and information relating to admissions, academic programmes, learner support services, examinations, and other academic and administrative activities. Students are advised to make good use of the website to stay informed about the latest announcements and updates. The link to access the website is <https://cdoejmi.ac.in/>.

Jamia Millia Islamia has a comprehensive website that is consistently updated with new notifications and updates about exams, counselling sessions, etc. The students are advised to make good use of the website to keep them updated with the new happenings at the University. 2.12 Assessment and Evaluation System

Evaluation System is divided into two parts at CDOE, Jamia Millia Islamia:

(i) Formative Assessment:

- Theory / Practical Assignments
- Dissertation/Workshop / Project Work / Practical/Viva-Voce (wherever applicable)

(ii) Summative Assessment

- Term End/Semester Examination

All the above are compulsory components for a learner of each programme of study (wherever applicable) to successfully complete the programme.

2.12.1 Term-End/Semester-End Examinations

The University conducts a Term-End Examination once a year and students are advised to take their examination at the end of each academic year, while the Semester-End Examinations are held twice a year at the end of each semester.

The examinations of ODL programmes are conducted through offline mode in the Jamia Millia Islamia campus and at different Learner Support Centres. However, for the online programmes, the examinations are conducted through Proctored Online Mode as per the UGC guidelines which are duly notified on the website of the office of the Controller of Examinations, JMI.

2.12.2 Theory/Practical Assignments

Assignments are an integral and compulsory component of the instructional system. The students will have to work on a specified number of assignments per programme. These assignments are to be submitted at the Learner Support Centre following the submission schedule provided by Programme Coordinator / In-Charge of the respective centers. The assignments are submitted through the Google Classroom of respective programme.

Dissertation / Workshop/ Project / Practical / Viva-Voce

In several programmes of study, students are required to do Dissertations / Projects / Practical, etc. (wherever applicable) as part of their coursework. These activities enable the students to have practical exposure and in-field experience. The Viva-Voce (if any) is held so that the learner may defend the practical activity that he/she has done during his/her Dissertation/Project/Practical.

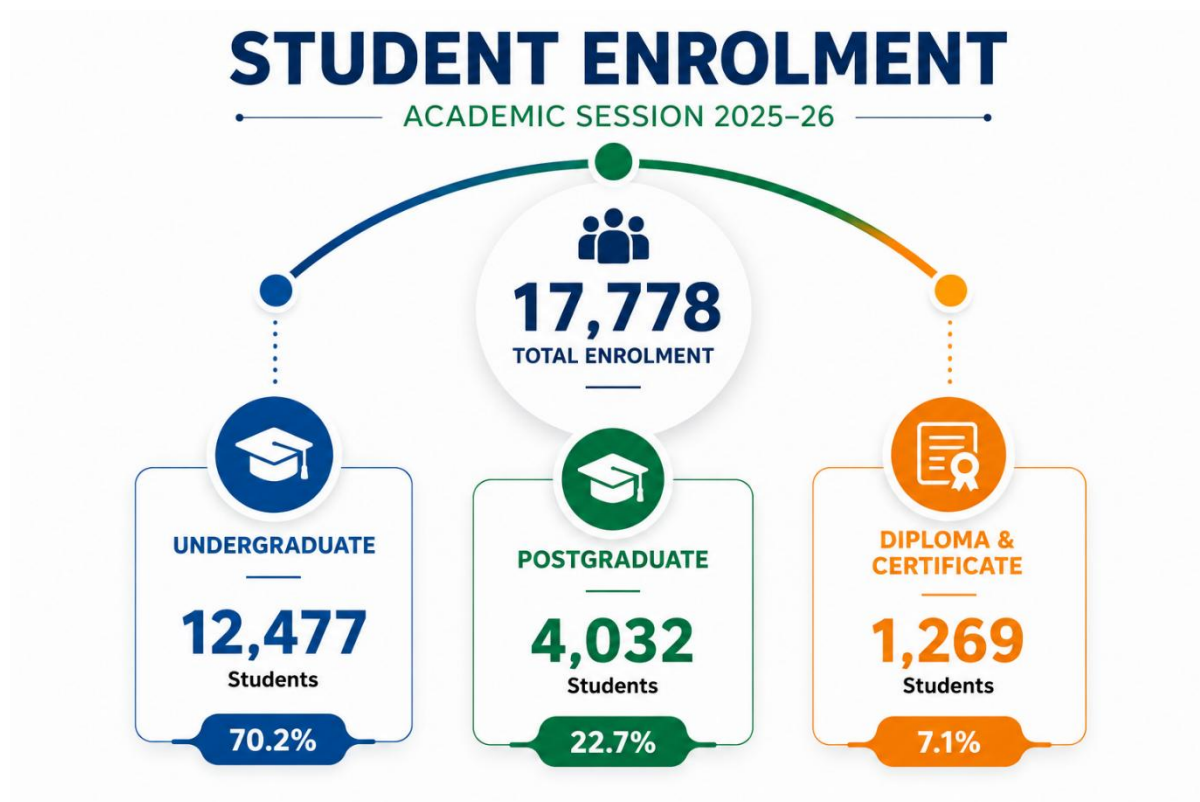
2.13 Grievance Redressal Cell

5. General Guidelines

Candidates are required to read the prospectus carefully before filling out the Application Form for admission to any Programme of study in CDOE, Jamia Millia Islamia, New Delhi. The Prospectus provides general information and is subject to the provisions of the Act, Statutes, Ordinances, Regulations, and relevant Resolutions of the Academic Council/Executive Council of Jamia.

The University reserves the right to change/modify the provisions made in this prospectus by notifying through addendum/corrigendum on the University website. Candidates shall not be informed of any such change individually and are advised to check the University website (<http://jmi.ac.in/CDOE/>) regularly.

5.1 Application/Registration Fee for Admission/ Entrance Test

- (i) The application for admission may only be submitted through Online mode at Jamia Millia Islamia Website www.jmicoe.in. There is no printed application form for admission.
- (ii) While applying, the candidate is required to make a payment of the Application Fee as prescribed below:

- (iii) The application fee may be paid either by Credit Card/Debit Card/ Net Banking.
- (iv) The application fee once received successfully at JMI's end is non-refundable and no correspondence on this subject will be entertained.
- (v) JMI shall only refund the application fee in cases of failed transactions identified at its end.

5.2 Submission of Application Form

- (i) Candidates are advised to carefully read and follow the instructions provided online during the Form Submission Process.
- (ii) To register for admission, candidates are required to use the online form available at JMI's Admission Portal: www.jmicoe.in
- (iii) Before applying for admission, a candidate is advised to ensure his/her eligibility as per the criteria laid down in the prospectus.
- (iv) A candidate must have passed the qualifying examination from a board/university/institute recognized by JMI. Jamia Millia Islamia recognizes degrees from all central universities, state universities, institutions of national importance, and foreign universities, provided that their equivalence has been established by the Association of Indian Universities (AIU). Besides, the university also recognizes certain qualifications from the reputed madrasas as well, the details of which are provided in [Annexure– I](#) of the prospectus.
- (v) Candidates whose results for the qualifying examinations have not been declared may also apply. However, for programmes whose eligibility is bachelor's degree, etc, they must submit the required certificates, etc. (of first declared result) within a given time period, failing which their admission will be cancelled.
- (vi) During the Registration process, the following information/details should be available with the candidate:
 - **Academic Bank of Credit ID (ABC ID) and UGC 'DEB-ID'. Both these IDs are to be created by the applicants themselves.**
 - A valid and readily accessible Email ID. Please note that, if required, JMI may use the registered email for future communication with the candidate.
 - Soft copy of candidate's color passport-size photograph with white background (Maximum 100KB in size) in JPG/JPEG format.
 - Soft copy of candidate's signature (Maximum 100 KB in size) in JPG/JPEG format.
- (vii) Candidates may use the preview option to cross-check the correctness of entries filled by them online before confirming the submission of the application form. Any required correction(s) except in "Name" and "Date-of-Birth" in the registration information may be made before completing/Confirming the registration portion in the form. The detailed guidelines for editing will be published on www.jmicoe.in.

- (viii) Once the registration of admission form is successfully submitted the system will send an email bearing the Unique Code with a link to verify the email account, and login (email address), and password to access the account to the registered email address. After link verification, and using an email address and password, the candidate may login to the portal and proceed to apply for the program(s) of his/her choice and pay the applicable entrance application fees.
- (ix) In case of submission of an Online form through Cyber I/at any other place, a candidate is also advised to go through the guidelines and get the form filled in his/her presence and provide his/her contact information such as email and mobile number wherever required. The University will not be responsible for any mistake made by the candidate while filling out the admission form.
- (x) Candidates are advised to bring the hard copy at the time of verification of documents. Print may be taken out after logging into the admission portal at: www.jmicoe.in
- (xi) Candidates may check the status of their application form on the JMI admission website i.e. www.jmicoe.in.

5.3 Rejection of Application Form

Jamia Millia Islamia reserves the right to reject the application form(s) if a candidate submits more than one application form for the same Programmes of study and for any other reason.

5.4 Conditions of Admission Cancellation

- (i) If a candidate fails to submit his/her result/certificate for the qualifying examination(s) or fails to complete any of the other admission formalities by the last date as notified by the University for the Concerned Program in this prospectus or on the University website.
- (ii) At any stage, if any information furnished by the candidate is found to be incorrect or if a candidate has been wrongly admitted.
- (iii) The candidate has to prove his/her academic records mentioned in the online application form, at the time of admission in CDOE and concerned Learner Support Centres, failing which admission will not be granted. Filling online admission form and issue of admit card does not guarantee admission.

6. Verification of Documents & Payment of Admission Fees

Documents will be verified at the time of admission. The applicant is advised to produce the following documents along with the programme fee at the time of verification.

- (i) Print out of the online submitted admission application form.
- (ii) 03 Passport size recent Photographs
- (iii) Class X Mark sheet and certificate (original and photocopy)
- (iv) Class XII Mark sheet and certificate (original and photocopy)
- (v) Graduation Mark sheet and certificate (original and photocopy), wherever applicable.
- (vi) Character certificate from the Institution last attended (In original). Character certificate shall not be older than six months. Or student may also submit an affidavit for the character certificate.
- (vii) Migration/Transfer Certificate, from the Institution last attended (photocopy)
- (viii) Copy of the Aadhaar Card.
- (ix) Must have passed the qualifying examination from a recognized Board/University/Institute.
- (x) Mention complete correspondence/postal address (in CAPITAL LETTERS only) with postal PIN code and contact telephone/mobile number.

Other Documents required at the time of document verification

- Experience certificate (wherever applicable)
- Diploma Mark sheet and certificate (original and photocopy), essential for B.Ed. admission.
- No Objection Certificate from the present employer (wherever applicable)
- The reservation and relaxation of 5% marks in minimum eligibility will be provided to SC/ST/OBC (Non-creamy layer)/PWD candidates as per the rules of the Central Government.
- Ex-students of the Jamia Millia Islamia must submit documentary proof for earlier enrolment numbers allotted by Jamia Millia Islamia.

NOTE:

- a. *The Jamia Millia Islamia recognizes degrees from all Central Universities, State Universities, Institutions of national importance, and Foreign Universities, provided that their equivalence has been established by the Association of Indian Universities.*

Besides, the University also recognizes certain qualifications from Madrasas, the details of which are provided in ([Annexure-I](#)).

- b. Verification of documents will be conducted through both online and offline modes. Candidates who are found eligible after the verification process will be permitted to proceed with the admission. Students verified through the online mode are required to submit hard copies of self-attested documents within the stipulated time.
- c. If a candidate submits forged/fake documents, he/she will be liable for legal/criminal proceedings.
- d. CDOE reserves the right to summarily reject any application form scrutinized for any discrepancy and incorrect information before finalizing admission.
- e. Students who are already enrolled in a programme of one year or longer duration can also simultaneously register for any Certificate/Diploma/PG Diploma programme. **However, if there is any clash of dates of counselling or examination schedules between the two programmes opted; the University will not be able to make adjustments.**
- f. No candidate shall be entitled to claim admission as a matter of right.
- g. Candidates are advised to regularly check the Centre for Distance and Online Education, Jamia Millia Islamia website (<http://jmi.ac.in/CDOE>) for admission-related notices and other information.
- h. After the verification of the documents, the students may proceed with payment of admission fees through the online link that will be provided **through email** by the concerned programme coordinator.

7. Post Admission Guidelines

7.1 Identity card

- (i) Identity Card will be issued only to students whose admission is complete in all respects (after due verification & payment of fees). CDOE learners holding CDOE I-Card can use the said ID during counselling sessions and to visit the CDOE Complex only.

- a. In case of loss of Identity Card, the students should file an FIR and submit a copy of the same along with a demand draft of Rs. 200/- in favour of the “Jamia Millia Islamia” payable at “New Delhi” in order to make a request for duplicate Identity Card.
- b. Admission will not be considered complete unless a candidate has a valid identity card issued by CDOE. Admission is liable to be cancelled if a student does not have a valid Identity Card issued by CDOE.
- c. Students are advised to collect the *Programme Guide* for the ensuing academic session from the Office of CDOE or their respective Learner Support Centres. The *Programme Guide* contains the Academic Calendar and other important rules related to counselling, assignments, examinations, and a detailed syllabus.

7.2 Cancellation of Admission and Fee Refund

- (i) In case of cancellation of admission, Programme fee will be refunded as per the following UGC guidelines:

** In case of (1) in the table above, the Higher Educational Institution (HEI) concerned shall deduct an amount not more than 5% of the fees paid by the student, subject to a maximum, of Rs. 5,000/- as processing charges from the refundable amount.*

** Fees shall be refunded by all HEIs to an eligible student within fifteen days from the date of receiving a written application from him/her in this regard.*

- (ii) A candidate would be admitted at a particular Learner Support Centre only if there is a sufficient number of admission seekers in a programme. However, if the number of admission seekers at a Learner Support Centre is inadequate, the following options are available to a student:
 - May be admitted at any other Learner Support Centre, including the Headquarters,

CDOE, where there are sufficient numbers of admission seekers if she/he wishes so

- May change the programme at the same Learner Support Centre, the fees will be adjusted accordingly
- May withdraw admission. In such a case, 100 percent programme fees will be refunded

(iii) A student who has paid programme fee will be given a Roll Number and Enrollment Number, which will also be mentioned in the Identity Card. The Enrollment Number and the Roll Number, thus allotted will continue for the maximum period allowed for the programme or until the programme is completed, whichever is earlier. The Roll Number will change only if one registers afresh for the same programme. The Enrollment Number does not change even if one seeks deferment.

7.3 Change of Optional Subject

A student shall not ordinarily be allowed to change the optional subject(s) of a programme (if any) unless the same is applied for and has been permitted by CDOE. Such applications should be submitted to the Dean, CDOE, through respective Program Coordinator. Change in an optional subject(s) is permitted after payment of Rs.1500/- for Self-Learning Material (SLM). The payment should be made through a Demand Draft drawn in favour of Jamia Millia Islamia payable at New Delhi.

7.4 Correction/Change of Name/Surname of Student

Spelling mistakes, if any, committed at the time of the data entry stage will be rectified at the Learner Support Centre and corrected data will be transmitted to the CDOE, for updating in the database. However, students are expected to write their correct name (as indicated in their Class X certificate) in the admission form. In case there is any change in the name (other than the one mentioned in a candidate's Class X certificate), the learner must furnish legal evidence while submitting the admission form.

- The following self-attested copies of certificates and documents are required to be submitted along with the admission application form:

General Instructions for Foreign/NRI Students and Foreign Diplomats in India

- (i) The program for which eligibility is to be relied upon must be from an institution included in the list of the Association of Indian Universities (<http://www.aiuweb.org>).
- (ii) In case the University/Board is not included in the Association of Indian Universities list, the candidate has to obtain and submit a Certificate of Equivalence to this effect from the Association of Indian Universities.
- (iii) Only English translations of all transcripts, duly attested, will be accepted.
- (iv) Candidates applying from their respective country should get their transcripts attested by the concerned accredited authorized government agency and also duly certified by the Indian Embassy or Consulate.
- (v) For candidates applying from India, all attestation must be done by the concerned Embassy/High Commission/Consulate of the relevant country in India.
- (vi) Applications without the attested documents shall be summarily rejected.
- (vii) On being granted admission, foreign students should produce their valid **Student Visa** and submit an attested copy of the same to the CDOE/Learner Support Centre.
- (viii) Upon arrival in India, every foreign student must register with the Foreigners Regional Registration Office (FRRO) within 14 days from the date of first entry into India as per the prescribed applicable procedure.
- (ix) NRI students will pay the requisite fees through a Demand Draft drawn in favour of Jamia Millia Islamia and payable at New Delhi, for their admission category throughout the duration of the programme even if they may not remain NRIs, i.e. their status changes from NRIs to Non-NRIs.
- (x) All foreign students (old/new) are required to fill out a Registration Form available with the Office of the Foreign Students' Advisor of the University, within 15 days of joining the course. Bonafide certificates shall not be issued if this stipulation is not complied with.
- (xi) The category once filled in the application form shall be final and cannot be changed at any later stage.
- (xii) The admission of foreign diplomats in India wishing to study in the JMI shall be governed by the prescribed applicable procedures and rules as notified by the Government of India from time to time. The fee structure for Foreign/NRI candidates will be applicable to foreign diplomats.

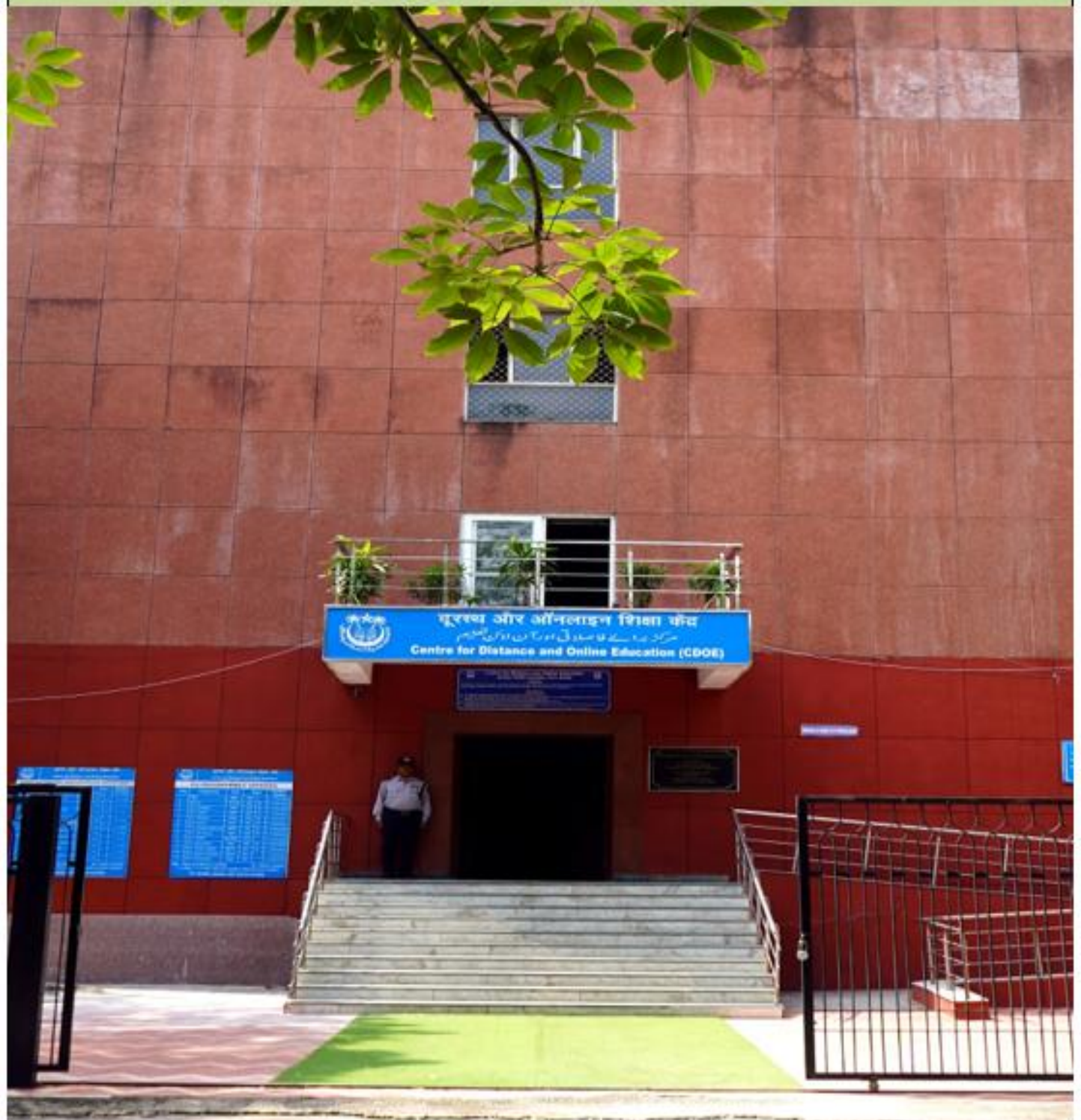
