 - c) Proof of age based on the certificate of High School/Secondary School or an equivalent examination.
 - d) Proof of permanent address (Voter ID card, Passport, Driving License and Aadhaar Card) as declared in the application form with the name of police station and District.
 - e) Muslim OBC and Muslim ST candidates will be required to submit their respective Category Certificate issued by the competent authority recently.
 - f) For candidates who have applied in the PWD category, certificate for disability is required from a Government Certified Authority.
 - g) Candidate seeking admission under Kashmiri Migrants Category will be required to submit a certificate in support of their claim of being Kashmiri Migrants obtained from registered Divisional Commissioner, of the concerned State.
 - h) Candidate seeking admission under Jammu & Kashmir category will be required to submit a state- domicile certificate in support of their claim for being from Jammu & Kashmir.
